More than ever, they need help not just from other government departments and agencies, but also from other international partners and stakeholders.



OUR CHAIR

IBMATA is chaired by leading border management expert Tony Smith CBE, a former head of the UK Border Force.

During his 40-year career, Tony served as Gold Commander for the London 2012 Olympic and Paralympic programme, which saw three million athletes, coaches, spectators and officials processed at the UK border for the competition on top of business as usual.

He also served as Regional Director for London and the South East in the UK Border agency, Head of Border Control in the UK Immigration Service and Head of Ports and Border Management in Citizenship and Immigration Canada.

Tony was awarded the CBE in 2013 for services to the safety and security of London 2012. After retiring from public service, he became Managing Director of Fortinus Global Ltd.




